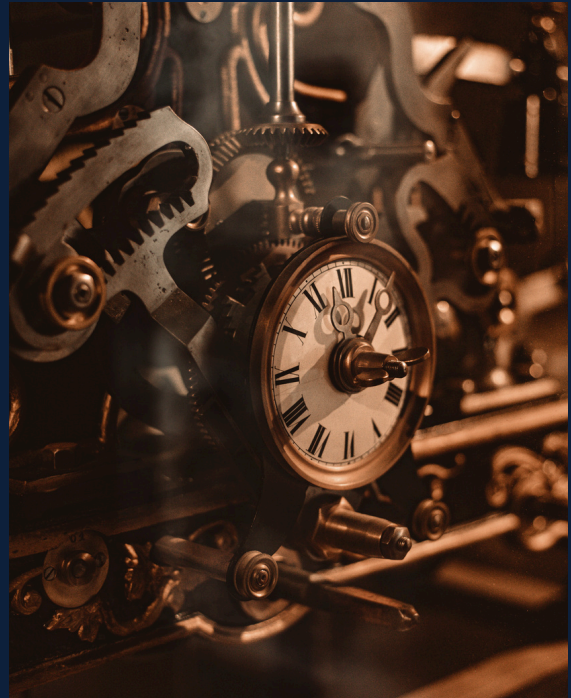

WORDS FROM THE DIRECTOR

Dear Community Members,

Every foster child's journey is unique, but they all share the same hope: to find safety, stability, and a permanent place to call home.

Our work is guided by the belief that permanency—whether through reunification, guardianship, or adoption—gives children the foundation they need to heal, grow, and thrive.

During 2025, our agency advocated for 82 children with the support of 42 dedicated volunteers.

Their commitment makes a meaningful difference in the lives of children navigating the foster care system.

January is also National Human Trafficking Prevention Month, a time to raise awareness and strengthen efforts to protect vulnerable children and youth.

Together, through advocacy and prevention, we can help ensure every child is safe and supported.

This is a new year. A new beginning. And things will change -
Help make the change for a child in foster care.

SUPERVISOR TIPS

1. Reconnect With Your “Why”

- Take a moment to remember what brought you to CASA.
- Think about one thing you hope to help your child achieve this year.
- Your presence and consistency matter more than you know.

2. Start the Year With Strong Habits

- Schedule your January child visit early to set the tone.
- Block time for documentation right after each contact.
- Review your case notes from last year to refresh your memory and identify next steps.

3. Refresh Confidentiality & Boundaries

- When in doubt about sharing information, pause and ask.
- Keep all child and family details private unless sharing with approved parties.
- Avoid posting anything case-related on social media—even vague references.

4. Prioritize the Child’s Voice

- Ask open-ended, trauma-informed questions.
- Check in on school, friendships, safety, and emotional well-being.
- January can be a tough transition month—your steady presence helps.

5. Essential Communication Skill.

- Keep communication professional, respectful, and child-focused.
- Be consistent and regularly make contacts with collaterals

6. Use Trauma-Informed Approaches

- Remember: behavior is communication.
- Offer choices when possible and validate feelings.
- Avoid leading questions—let the child tell their story in their own way.

The best thing you can give a foster child is unwavering support.

SUPERVISOR TIPS CONTINUED

7. Reach Out Early and Often

- If you hit a roadblock, don't wait—contact your supervisor.
- Bring questions, concerns, or ethical dilemmas as soon as they arise.
- You're not expected to know everything; you are expected to ask.

8. Set One or Two Advocacy Goals

- Examples:
 - Strengthen school communication
 - Strengthen relationships with DCFs
 - Build rapport with the placement
 - Increase meaningful child engagement

9. Take Care of Yourself

- Advocacy is meaningful but emotionally heavy work.
- Set boundaries, take breaks, and ask for support when needed.
- Sustainable advocacy is better than perfect advocacy.

10. Strengthen Documentation Practices

- Submit contact logs within 24–48 hours to keep details accurate.
- Use templates for court reports to stay organized.
