CASA of West CenLA is made up of In order to advocate for the children our volunteers community members from Vernon Parish, had to adapt, children in our community are safe, nutured, thriving and have the opportunity to enjoy their childhood. Over the past 18 years CASA of West CenLA has advocated for the best interest of children in our foster care program. The children we serve have been placed in difficult situations due to no fault of their own. This work has been and continues to be performed by numerous community volunteers advocating for our children.

During 2020, we have all navigated challenges that made it difficult to complete this important work. Our agency volunteers, board members, staff and our awesome community continue to meet and overcome each and every challenge. Our 45 volunteers advocated for 75 children throughout this calendar year. In doing so the volunteers had 596 contacts with the childten, accumulated 757.5 hours, drove an excess of 9662 miles, authored 45 court reports and attended 46 hearings. The efforts of the volunteers contributed immensely to the reunification of five children with their families and the adoption of 22 children.


